

## GSV Capital Corp. Announces Adjustment to Conversion Rate of 5.25% Convertible Senior Notes Due 2018

WOODSIDE, Calif., Aug. 24, 2016 (GLOBE NEWSWIRE) -- GSV Capital Corp. (the "Company" or "GSV Capital") (Nasdaq:GSVC), today announced an adjustment to the conversion rate of its 5.25% Convertible Senior Notes due 2018 (the "Convertible Senior Notes"). The adjustment to the Convertible Senior Notes was made as a result of the cash dividend declared by the Company's Board of Directors on August 3, 2016, which is payable on August 24, 2016 to the Company's stockholders of record as of the close of business on August 16, 2016 (the "Record Date").

As a result of the dividend, effective after the close of business on the Record Date, the conversion rate of the Convertible Senior Notes adjusted to 83.3596 shares of common stock per \$1,000 principal amount of the Convertible Senior Notes, which is equivalent to a conversion price of approximately \$12.00 per share of the Company's common stock, from the conversion rate of 82.7567 shares of common stock per \$1,000 principal amount of the Conversion price of approximately \$12.08 per share of the Company's common stock. The Convertible Senior Notes mature on September 15, 2018, unless previously repurchased or converted in accordance with their terms.
